## **General Information**

#### **JVMPF CAMP ATTENDANCE**

A child must be present to be available for learning; therefore, we believe that it is pointless for your child to be in the JVMPF program without regular attendance at summer camp. Regular attendance is the mutual responsibility of the child and the family.

Weekly attendance is mandatory. If your child has 2 or more absences (excused or unexcused) in one week, you will be contacted about whether he or she wishes to continue the summer camp. Please remember that we have a waiting list for students wanting to enroll in the Summer Arts Camp.

#### **PUNCTUALITY**

Getting to camp on time, ready to learn fosters a good attitude and forms the habit of using time wisely. Therefore, we encourage our students to arrive at Summer Arts Camp on time (i.e. between 7:30 AM-8:00 AM) since we only have a short time to cultivate our learning abilities. Please make sure that you call or text before the start of camp if your child will be absent.

Note: Your child may be removed from the program if he/she only shows up in the afternoon only or shows up late three times in one week.

\*Please try to schedule any appointments or any other family obligations in the afternoon hours. \*

#### **ARRIVAL & DEPARTURE - Signing In and Out**

A parent, guardian or listed caregiver must park, come into the camp area and sign the camper in at arrival and out at departure each day. Whoever is picking up your child MUST come in to the gate and make direct contact with Adult Sign In/Out Attendee before taking their child. If your child is still inside, please come inside and make contact with an adult before leaving with your child.

If your child will be going home with someone other than a Parent, please send a signed
note identifying the individual that will be picking up along with the time they will be
taking your child. (Note: If this person is not on the list of names you provided on
application, you will need to call us in advance.) Please advise anyone picking up your
child that the JVMPF may request a picture I.D at the time of pick-up.
JVMPF cannot be responsible for sleepover luggage and other extra
belongings. Please make sure that the person picking up your camper
knows to collect all the camper's belongings.
Occasionally camp may run behind schedule. If this occurs, please wait
patiently for your child to be brought to you or return from an outing. (ex.
swimming or field trip)

If you need to pick up your camper before the end of the camp day (5pm), please send a note indicating the pick-up time. Staff will ensure that your child is at the JVMPF at the indicated time. If you must pick up your child unexpectedly, contact the Camp Director at 954-770-9148. Always remember to sign your child out.

### We have ONE ENTRANCE and EXIT of PROPERTY

The Summer Arts Camp will be held at the Ahmanson Club House (next to the basketball court). Students will enter and exit on Robinson Street (by the playground). You will sign your child in by the playground. If your child is late you must come inside to sign him/her in.

## **ATTIRE and PERSONAL BELONGINGS**

Campers are required to wear comfortable "play" clothes. Please be advised
that some camp activities and crafts may involve washable paints or
materials that may soil clothes.
For the safety of your child, we ask that campers wear tennis shoes or
closed-toe, closed back shoes with rubber soles. Flip flops and shoes with
open toes are permitted but <i>not</i> advised.
Campers may <b>not</b> bring toys from home, electronic games, etc. to camp. The
JVMPF Camp provides appropriate games and activities for all camp
activities.
Campers do not need money throughout the day except for change for the
Snack Shack, if you choose to give it to them. All money needed for
activities should be given directly to their teacher as you sign them in
MONDAY AND WEDNESDAY are swimming days. Campers need to bring
a swimsuit and towel if they wish to go swimming. They must have clothes
to wear after swimming as well.
**Cellphone Policy- Please Read**
Campers may not bring a cell phone (or tablet, laptop, or similar device). If
parents need to get in touch with their child, they can call the Camp Director
or their child's teacher, and the child will also be able to use a teacher's
phone if needed to contact their parent.
If they do bring a phone they will not be permitted to use it during the day. It
will be placed in a central location in the morning and can be retrieved at the
end of the day when they get picked up. JVMPF is not responsible for any
cell phones or electronic devices that are brought without permission.

☐ Campers must have a medical information form on file with JVMPF that identifies individuals and/or physicians to be contacted in the case of an
emergency and lists any physical limitations or impairments and medication
(and side effects) your child may be taking.
☐ Please notify the Camp Director if your child is taking any medication that might affect his/her behavior in camp.
☐ The JVMPF camp staff does not dispense any medication. Do not send medication in your child's book bag.
☐ In the event of an accident or injury that requires first aid, an accident report will be completed and parents will be notified by phone. A copy of the accident report will be sent home for your personal records.
☐ Campers may not attend camp with a fever. Any child who has been nauseated or who has vomited during the evening should not be in camp the following day. Children must be fever free with no vomiting or nausea for 2 hours to return to camp.
☐ Campers should not attend camp if they have an unexplained rash, diarrhea, discharge from the eyes or ears, or any symptoms that are cause for concern to JVMPF staff. A parent will be called to pick up their child immediately if JVMPF staff notices any of the above mentioned symptoms or others.
☐ Please notify the Camp Director if your child has been exposed to any germ or communicable conditions that could be shared with other campers or staf members.
<u>DISCIPLINE</u>
☐ The JVMPF camp staff believes in positive, affirming discipline that allows for a personally enriching camp experience. Camp staff and counselors will use positive language and reinforcement to help guide a camper to make safe, positive choices. Our camp leaders and counselors are ready to work with parents to make sure their child feels nurtured and encouraged in the JVMPF camp environment.
☐ Disciplinary actions will be taken if needed and will include a warning,
time-out, and parent contact.
☐ If a camper is a constant disruption in the camp and is not responding to
the camp leaders' guidance, the Director will call a parent to discuss
alternate options. If the behavior continues, the camper may be asked to
stay home (with no refund of Camp fees).

# John & Vera Mae Perkins Foundation Youth Programs COVID-19 SAFETY PROCEDURES

Dear Parents & Families,

The health and safety of our students and staff is always our number one priority. We will do everything in our power to maintain a safe, clean environment for your children to learn and grow, and we expect your commitment to the same. Please read the following Covid-19 Safety Procedures carefully. We reserve the right to update our policies at any time depending on CDC recommendations and/or local statistics.

- If any sibling, parent or member of the household has tested positive for Covid within the
  last 5 days, student/staff will not be permitted to attend camp for one week, even if their
  own test is negative.
  - Please notify the Camp Director IMMEDIATELY if a member of your family or household has tested positive for Covid
- Students and staff members are encouraged to wear a mask when attending field trips.
   Please send your child with a mask if you would like them to wear one on field trip days.
- Students and staff will be monitored closely for symptoms. If any of the following symptoms are present\*, student/staff will be sent home and can only return when symptoms have subsided
  - o Fever or chills
  - Cough
  - Shortness of breath or difficulty breathing
  - Fatigue
  - Muscle or body aches
  - Headache
  - New loss of taste or smell
  - Sore throat
  - Congestion or runny nose
  - Nausea or vomiting
  - o Diarrhea

<sup>\*</sup>If your child has allergies, make sure they have taken their medicine. Some of the symptoms of their allergies may overlap with these symptoms and cause them to be sent home
